Re: <u>Allotment of Equity Shares on Preferential basis</u> - <u>Regulation 30 of the SEBI (Listing Obligations and Disclosure</u> <u>Requirements) Regulations, 2015</u>

(1) This is to inform you that the Company has allotted 1,94,17,400 Equity Shares of \gtrless 2/- each to Bengal & Assam Company Ltd. and BMF Investments Ltd., constituents of the Promoter Group of the Company on preferential basis, at a price of \gtrless 103/- per Equity Share (inclusive of premium of \gtrless 101/- per Equity Share), on the terms of Issue approved by the members by means of a special resolution passed at their Extraordinary General Meeting held on 22nd March 2019.

(2) Further, after the allotment of Equity Shares as aforesaid, the paid-up capital of the Company stands increased from \gtrless 45,36,26,960/- divided into 22,68,13,480 Equity Shares of \gtrless 2/- each to $\end{Bmatrix}$ 49,24,61,760/- divided into 24,62,30,880 Equity Shares of $\end{Bmatrix}$ 2/- each. Also, the shareholding of the Promoters and Promoter Group of the Company stands increased from 11,90,32,655 Equity Shares (52.48%) to 13,84,50,055 Equity Shares (56.23%).

(3) We may inform that the Company has already received *in-principle* approval vide letter no. NSE/LIST/20252 of National Stock Exchange of India Ltd. and Letter No. DCS/PREF/SD/PRE/3584/2018-19 of BSE Ltd., both dated 18th March 2019.
