In terms of Section 110 of the Companies Act, 2013 (Act) read with the Companies (Management and Administration) Rules, 2014 (Rules), the Board of Directors of JK Tyre & Industries Ltd. (the Company) at its Meeting held on 28th December 2016, has appointed me as the Scrutinizer for conducting the postal ballot voting process (including voting through electronic means) in respect of the following proposed Special Resolution(s):-

Type of Resolution(s): Special

Issue of Securities, specified in the resolution(s), in one or more tranches, for an aggregate amount not exceeding ₹1,000 Crores.

On the basis of documents produced, information furnished and verification of postal ballot forms received/e-voting cast by the members of the Company, I submit my report as under:

1. The dispatch/email of the Postal Ballot Notice dated 28th December 2016/Forms along with postage pre-paid business reply envelope to 88,758 Members of the Company whose name(s) appeared on the Register of Members/List of Beneficial Owners as on 23rd December 2016, was completed on 4th January, 2017 and Newspaper Advertisement(s) in compliance with the provisions of the Act was published on 5th January 2017.

- 2. The Company provided electronic voting facility (e-voting) to the Members of the Company through platform provided by Central Depository Services (India) Ltd.(CDSL).
- 3. The voting period, both through physical postal ballot and through e-voting, commenced on 6th January 2017 (10.00 A.M.) and ended on 4th February, 2017 (5.00 P.M.).
- 4. Particulars of all the Postal Ballot Forms received in physical form from the members and e-voting have been entered in a register maintained separately for the purpose.
- 5. All the Postal Ballot Forms received and e-voting cast upto 5.00 P.M. on Saturday, 4th February, 2017 i.e., the last day and time fixed by the Company for the receipt of the postal ballot forms/e-voting, were scrutinized by me.
- 6. No Postal Ballot Form received after 5.00 P.M. on Saturday, 4th February, 2017 has been considered by me and the e-voting facility to the Members was disabled at 5.00 P.M. on Saturday, 4th February, 2017.
- 7. The votes cast by members electronically were unblocked on Saturday, 4th February, 2017 at 5.12 P.M. in the presence of two witnesses, Ms. Sonia Bansal and Ms. Aarti Kumari, who are not in the employment of the Company.
