This is in supersession of the resolutions of the Board of Directors for raising of funds by issue of Non-convertible Debentures as informed to the Stock Exchanges vide our Letter No. JKTIL:SECTL:SE:2016 dated 9th November 2016.

The approval of the members in this connection, will be obtained by way of a Postal Ballot, the notice of which along with other relevant details being sent to the members will be submitted to the Exchange separately.
